



## EU General Data Protection Regulation (GDPR) Privacy Notice

Reign Capital Limited (hereinafter (“**Reign Capital**”) or (“**RC**”), understands privacy concerns and strives to comply with data protection laws. This document explains our website privacy notice:

- the types of personal information we collect about visitors on our website
- how to contact us about our privacy practices and visitors’ privacy rights
- how we may use and share the information we collect from visitors
- the choices visitors have regarding the use of personal information
- the steps we take to protect visitors’ personal information
- how long do we keep visitors’ personal information

This privacy notice applies to the processing of personal data linked to the use of Reign Capital’s website: [www.reigncapital.co.uk](http://www.reigncapital.co.uk) and across all our social media channels.

Reign Capital, as a Data Controller, is committed to complying with the General Data Protection Regulation 2016/679 (“**GDPR**”) and all applicable data protection laws and regulations.

Reign Capital wants to ensure that visitors understand what personal data is collected about themselves, how it is used, and the security measures applied for their safety when using the Reign Capital website.

### 1. What personal data do we collect?

First name, e-mail address, and category of request (visitor’s request - information request - other).

### 2. Why do we use your personal data?

We use visitors’ personal data to respond to their requests or queries via [info@reigncapital.co.uk](mailto:info@reigncapital.co.uk) and across all social media platforms.

### 3. How long will we keep your personal data?

The length to which we store visitors’ data is subjected to the inquiry or requests for information being asked. We, therefore, retain visitors’ data for as long as is necessary to fulfill this purpose.

### 4. Data sharing

We do not sell, trade, or rent visitors’ personal data to third parties.



We only pass visitors' personal data to our partners and/or subcontractors to the extent necessary to fulfill the purpose of processing visitors' data.

Some of our partners and subcontractors may be located outside the European Economic Area ("EEA"). In this case, visitors' personal data may be transferred to countries that do not have the same level of protection for visitors' personal data as the EEA. This does increase the risk that visitors' may not be able to exercise their rights. In the event that visitors' personal data is transferred outside the EEA, RC is NOT responsible for protecting visitors' personal data and taking steps to maintain the confidentiality of visitors' data.

## **5. How do we protect your data?**

Reign Capital treats visitors' personal data confidentially and uses at least the same level of care to protect visitors' personal data as it does its own confidential information internally of a similar nature.

Visitors' personal data is held on secure networks and is only accessible to a limited number of administrators who have specific access rights to these internal systems, and are equally required to maintain the confidentiality of the information.

## **6. Your rights**

In accordance with the GDPR, you have the following rights:

- **Information:** Where personal data is collected directly from the data subject or obtained from another source, it is necessary to inform the data subject of the use of that personal data by Reign Capital and of the data subject's rights in relation to that data – set out in the "Privacy Notice".
- **Access:** Visitors' have the right to obtain a copy of their personal information, confirmation of their processed personal data and, if necessary, any additional data to make the process transparent.
- **Rectification:** Visitors' have the right to request rectification of inaccurate data concerning them.
- **Erasure:** Visitors' have the right to request the erasure of their data in certain circumstances.
- **Restriction of processing:** Visitors' have the right to request restricted processing of data in certain circumstances.
- **Data portability:** Visitors' have the right to request the receipt of their personal data information or transfer it to another organisation in a machine-readable format.
- **Objection to processing:** Visitors' have the right to object at any time, on grounds relating to certain circumstances, to the processing of their data.
- **Right to withdraw consent:** Where visitors' have given their explicit consent to the processing of their data, they may withdraw it at any time without justification. Withdrawal of consent will not affect the lawfulness of the processing based on the consent prior to its withdrawal.
